**Fees to be paid in 18 monthly installments on the first day of every month from last date of service (conception) until weaning at 6 months PLUS any vet costs associated with the pregnancy or foaling.**

**Mare choice may be limited or changed at discretion of YSH before purchase.**

### CONDITIONS

- YSH will be responsible for any costs associated with Stud Returns & Foal registration but reserves the right to place the prefix Yalkin to the foals registered name. (IE: Yalkin + Name chosen by Purchaser)
- YSH will provide the Purchaser with the weanling's registration papers at the finish of this agreement when the purchaser takes collection of the weanling.
- Further registration, membership and/or transfer costs will be the responsibility of the Purchaser.
- All outstanding costs & fees must be paid in full before collection of weanling resulting from this agreement.
- Any delay in finalizing of this agreement at the 6 month weaning will result in agistment fees being charged at \$40 per week for the care of the weanling. These costs will be added to any outstanding fees or costs.
- If any outstanding amount is left in arrears longer than 28 days the Purchaser forfeits all rights to the foal/weanling & any fees or costs paid prior to default.
- Vet fees associated with the pregnancy will be charged directly to the purchaser. YSH will supply the Purchaser's details to the vet for invoicing. If any outstanding vet fee is left in arrears longer than 28 days YSH reserves the right to cancel this agreement & the Purchaser will forfeit all rights to the foal/weanling & any fees or costs paid prior.
- YSH would appreciate the Purchaser informing YSH of their intent to visit during the time of this agreement to view the mare and/or foal so an appropriate time can be arranged.
- Entry to the property without prior arrangement will be a breach in this agreement & YSH reserves the right to cancel & the Purchaser will forfeit all rights to the foal/weanling & any fees or costs paid prior should this occur.
- YSH will take all care for safety & health of the mare and foal/weanling during the time of the agreement but horses being horses, no responsibility for injury to the foal/weanling will be accepted.
- Death, humane destruction or injury of the foal/weanling during the time of this agreement will be the purchaser's risk.
- In the event of the death or humane destruction of the foal/weanling or mare during the time of this agreement the Purchaser may negotiate with YSH to transfer agreement to another choice of dam, if available, or take out a Future Foal Purchase at a discounted price for the following season, if mare still available. (discount by negotiation)
- Specialized care (ie: feed/supplements) or handling of the mare and/or foal during the agreement period by prior arrangement, within reason.
- Conditions may be modified by negotiation, at the discretion of YSH, & will be confirmed in writing. Copy of changes will be given to Purchaser.
